8. REPORT OF POLICE OFFICER

12. PLANNING

Councillor Morley Thomas made the following statement:

"In commenting on this application I should make it clear that my comments are based on the information currently available and do not commit me to taking the same position when the matter is discussed at the District Planning Committee and full information is available.

13. PARKING (RL)

Councillor Lee expressed increasing concern at the problem of parking/congestion in the streets within St Just and Pendeen. There appears to be problems in most town and villages and Councillor Williams stated that the same problems were being experienced in Pendeen along the main B3306. It was agreed that part of the problem was that planning permission was now being granted for dwellings without consideration for onsite parking. Councillor Thomas stated that parking was now not an essential planning consideration.

This was a subject to be considered at every level of local government and the Clerk was instructed to contact the Divisional Surveyor and arrange an informal meeting to discuss this matter together with any other highway issues considered important.

14. PENWITH BUDGET(RL)

Councillor Lee enquired if District Councillors were invited to have any input when setting the District Council budget. He felt that consultation with Parishes on what was required by the public should be an important consideration. Also he felt it was not in the interests of this area that no District Councillor was currently on the Resource Committee

15. FINANCE COMMITTEE(BR)

Councillor Rees felt it would be in the interest of this Council to set up a Finance Committee.

The Clerk informed the Council that this could be considered at the next AGM in May when all Committees would be rescheduled – until then the Internal Audit Committee could undertake items of a financial nature if required. Agreed.

16. SPEEDING TRAFFIC IN FORE STREET(MT)

Councillor Thomas expressed concern that he had received reports of vehicles speeding in Fore Street and causing a real danger to pedestrians particularly. He believed that the road could be reclassified as a B road (instead of the existing A) and then a 20 mph limit could be introduced.

It was agreed that this item could be discussed with the Divisional Surveyor on his intended visit.

17. CHRISTMAS WINDOW COMPETITION(SS)

The Mayor stated that she had been approached by the St Just Traders Group regarding the possibility of the Council organising the above competition and awarding annual cups for the event.
