c)Environment Agency - response letter

The Clerk read a letter of response to this Council's enquiry from the Environment Officer of the above Agency regarding concerns at the quality of the water in the Cot Valley and Tregeseal rivers.

The response stated that due to financial restraints on the service they had been forced to make cut backs in this type of monitoring service although the output from the sewage treatment works at Tregeseal is still routinely monitored as this is funded by the charges raised against the consent to discharge for the site.

The Officer appreciates the genuine nature of the concerns and suggested that Councillors use and promote the use of the Agency freephone incident hotline – 0800 807060 to report any pollution incident as soon as possible following the event and secondly that if the Council was able to be more specific with details of the areas of concern there may be specific sites or land use practices that would benefit from pollution prevention visits by the Agency.

The Council noted this response.

The Mayor had been asked to meet with a representative from the French town of Brec'h to receive a gift from their Mayor. The Mayor and the Clerk were authorised to purchase an appropriate gift in return to exchange at the proposed informal meeting.

f)<u>Carn Bosavern – No waiting Time restrictions and Limited Waiting</u> Parking Bays

The County Council had made a decision on the above proposal after taking into account the results of the consultation. Letter as follows:

"Due to a number of suggestions regarding the times covered by the limited parking bays, the restrictions have now been amended to Monday to Friday, 8 a.m to 5 p.m., 30 minutes no return within 2 hours. It was felt that there is no need for restrictions on a Saturday and after business hours during the week. The positioning of the two limited waiting parking bays will be as advertised.

There was limited objection to the double yellow lining along Carn Bosavern. The only amendment to these restrictions will be to terminate the lines at the junction at
