13. IDEAS TO ENCOURAGE AFFORDABLE HOUSING DEVELOPMENT (SJ)

Councillor James raised the above subject for Council discussion. It was agreed that the subject of Community Land Trusts be looked into in more detail by contacting Mr Alan Fox of the Cornwall Rural Housing Association and inviting him to meet with the Town Council and possibly representatives from Penwith's Affordable Housing Department and look at the subject in more detail.

14. SUPPORT FOR FARMERS MARKET IN PENDEEN/ST JUST (SJ)

Councillor James raised the above subject in response to requests through the MCTI recent survey which had identified the issue as one of interest to the wider community.

Considerable discussion took place on the benefits or possible detrimental impact such a market could have on the communities of St Just and Pendeen. In general it was felt that as the MCTI had not been successful in obtaining funding for this project and that a feasibility study would be required it was unlikely to get support. Councillor Thomas stated that such a

Market would need an organizer and Councillor K McFadden stated that such a market should not be considered for Market Square due to the existing parking problems there. Councillor Smith stated that a survey had at one time identified the Town Hall as being appropriate venue for a Farmers Market. It was agreed that such a project would need to be structured and that it could jeopardize existing businesses as market stalls had none of the usual business overheads to take into account.

A proposal to explore the possibility of a farmers market was lost by 6 votes to 5.

Councillor S Angove entered at this point of the meeting.

15. UNITARY AUTHORITY - TOWN COUNCIL INVOLVEMENT (SS)

Councillor Smith raised the above subject and the fact that the Council had not completed sections 2 and 3 of the One Cornwall Survey to identify the ambitions and interests of the Council in the provision of future services.

Councillor Angove stated that she had been appointed to the Implementation Executive as a representative to CALC.

It was agreed that the Town Council completes the survey as mentioned above at the next Planning Meeting scheduled to be held on 4th February 2008.

16. NEW TRACK AND BARBED WIRE FENCING AT TREVEDRA CLIFF/GWENVER (CMc)

Councillor McClary stated his concerns that this new track had been excavated, heavily fenced and signed with "private" notices. In his opinion it was detrimental to the visual impact of the area and a real eyesore. The District and County Councils had been aware of the situation for some time but no visible action had been taken to date. According to local information there was no evidence of a previous track and this could set a precedent for the future.

On a proposal by Councillor McClary, seconded by Councillor Smith, the Council instructed the Clerk to write to the County and District Councils and ask them to identify the legality or otherwise of the track and the concerns at the infringement of the public rights of access under the Open Countryside legislation.

17. BANNING OF PLASTIC BAGS IN TOWN AND DISTRICT - TRADERS RESPONSE(CMc)

Councillor McClary raised this issue following the discussion at the meeting in November 2007

(2709) where it was agreed to bring the matter to the attention of the Traders Association in St Just for comment.

Councillor Thomas stated that it had been brought to the attention of the Traders Association -

although they had agreed it was a good idea felt it would not always be possible to operate

such a scheme. Councillor Stevens stated that the local Co-op should be approached in the

place and then public opinion could be sought on the subject. More enquiries to be made on

the matter and reported back in due course.
