13. ALLOTMENT UPDATE AND FUNDING (DS)

Councillor Stevens stated that this project was progressing. Town and Parish Councils were now being encouraged to apply for funding particularly if they were working in partnership with a community group such as the Allotment Society. He stated that he would be meeting with a local land owner in the near future to discuss the matter further. With the Town Council budget allocation of £4000 that could attract £40,000 in Lottery funding for such a project. The Council voted unanimously to progress the matter further if possible.

The Clerk reminded Councillors of this forthcoming Training after the next Planning Meeting.

15. APPLICATION TO USE THE PLAIN AND GWARRY – St Just and District Trust Plain Project

2nd to 9th August 2008 various events in the Plain. Miracle Theatre, Barn Dance and other events.

The Council were pleased to approve the application, but asked that the applicant be informed that the Council requires that the entrance to the Plain is not obstructed by vehicles parking on the pavement.

16. CORRESPONDENCE

a)<u>Nancherrow Bridge Strengthening Works - letter from CCC</u>

A letter had been received regarding the proposed strengthening works proposed for the bridge over the B3306 at Nancherrow. The Council stated that the visual identity of the bridge was important and should be retained and that the contractors working for the County be made aware that there is (allegedly) an ancient cross incorporated into the structure of the bridge

b)Letter from PDC – re One Cornwall Community Networks

This letter suggested a meeting of the Town and Parish Forum be arranged to discuss Community Networks. The Clerk had contacted Sally Newby some weeks ago for a suggested date of a meeting.

c)Fields in Trust - info from NPFA (circulated)

The Clerk circulated this information regarding the concern at the disappearance of Playing Fields. More than 250 fields are at threat of development. It is feared that disposal of sites within Cornwall could follow the creation of a Unitary Authority. Noted.

d)<u>Fly-tipping at Lafrowda Close – communication with PHA</u> The Clerk reported incidents of fly-tipping in the residential areas at Lafrowda Close,

possibly by persons not resident in that location. It was becoming a matter of real concern to the residents and PHA. Councillors were asked to be observant and seek information on those responsible for this offence.

f)PDC - letter re removal of telephone kiosk at Tregeseal.

The kiosk at Tregeseal, opposite Fernlea, was scheduled for removal. This kiosk had no lights and was for card users only so had very limited public benefit. The Clerk stated that after making local enquiries she believed that the facility is rarely used and of little value to the community.

The Council agreed that they could not justify its retention based on the above information.

The Clerk was instructed to inform Mr McKenna that the Council adheres to its decision of 1st October 2007 not to support the project any further. It had granted £250 in 2004 and £250 in 2007.
