6. REPORT OF DISTRICT COUNCILLOR

Councillor Thomas informed the Council that from 1st September funding was being made available from the Government to the CAB for a Court Desk Service. Publicity on the matter would be available soon.

7. REPORT OF THE COUNTY COUNCILLOR

Councillor Angove spoke on the proposed Post Office closures. The County Council would be launching a legal challenge although this is in the early stages.

The Implementation Panel continues to work towards the re-organisation next April.

8. REPORT OF THE POLICE OFFICER

In the absence of a Police Officer the Town Clerk read the report.

There had been a total of 17 reported crimes compared to 39 for the same period last year.

4 criminal damage to vehicles, 1 dwelling burglary, 1 criminal damage, 1 assault ABH, 1 Drunk and disorderly, 2 thefts, 2 possession of drugs. 5 reported domestic related incidents.

Other issues: Complaints of youths in the Playing Field causing noise nuisance at night.

Motorbikes using coastal footpaths and moorland areas. Parking concerns, alleged lack of enforcement. Dangers of driving at speed, not using a seat belt and driving while using a mobile telephone are the subject of a joint Operation with Traffic Officers.

10. MATTERS ARISING FROM THE MINUTES

a)One Cornwall - update

Councillors had been circulated with a copy of Issue 12 Newsletter.

A News Release stated that the Boundary Committee have accepted the proposal for 123 Councillors for the new authority but the timescale does not allow the proposals to be implemented in time for next year's elections. A decision will have to be made on when the proposals will be brought into effect and that could mean further elections before the end of the normal four year cycle.

Information had been received on proposals for twenty-two One Stop Shops to be up and running by 1st April 2009. These will be located all over the County where public can walk in and gain information, advice and guidance.

b) CCTV - commencement of maintenance contract.

c)Result of recent election of Councillor W F East.

As a result of the recent uncontested election Councillor W F East of Higher Botrea Farm Newbridge was elected as a St Just Town Councillor after signing his Declaration of Acceptance of Office.

d)CCC Carn Bosavern - No waiting restrictions and limited parking bays

County Highways had written to inform the Council that the Police have requested that the Limited Waiting Parking Bay outside the Recreation Centre be reduced by four metres at the western end to reduce the risk of obstructive parking on the bend. The works to be carried out by Cormac in the near future.

e)PDC - construction of footpath at Tregiffian/Trevedra cliff

A letter of response from the Sustainable Development team had stated that the letter would be passed to the appropriate officer when he returns from annual leave.

f)Bosorne Road/Regent Terrace – proposed stopping up of highway – referred from last meeting on 14th August 2008.

This matter was reconsidered in the light of new information relating to objections to the proposal.

On a proposal by Councillor C McClary seconded by Councillor B Rees the Council resolved to reverse their decision on 21/7/08 page 2810 and now resolved to refuse to consent to the application being made for the stopping up of the highway as detailed.
