TC.28 PUBLIC REQUEST TO ADDRESS THE TOWN COUNCIL

The Town Council received a presentation from Alyson Wynn who was working as a consultant to the Cape Cornwall Surgery looking into a prospective solution to the lack of NHS dental services in the West Penwith area. Ms Wynn outlined the historical background to the development of NHS dentistry and its relationship with the Primary Care Trust (PCT) and the aims of the proposal to establish a new build two chair NHS dental surgery in Cape Cornwall Surgery by mid 2010.

A questionnaire had been circulated to the local community which demonstrated that 80% of those who had returned the form found difficulty in accessing an NHS dentist.

The Town Councillors were supportive of the proposal in principle but sought assurances that if the facility was opened, residents from the St Just and Pendeen areas would be given priority over people from other areas within West Penwith.

Councillor Angove commented that she believed that the PCT would allocate priority on postcode areas. Ms Wynn said that during her discussions with the PCT this had not been mentioned, but she agreed to look into the issue and provide the Town Council with a response.

The Town Council expressed some concern that a new dentist surgery might be provided at the expense of others, and referred to the loss of the podiatry service which had provided an excellent service to local residents, particularly the elderly, and was now located in Penzance.

The Town Council requested that a further meeting be arranged with GPs from the surgery who would be able to provide further details on the proposed project and respond to questions. It was **agreed** that Ms Wynn would liaise with the Town Clerk over the arrangements for a further meeting.

09-0533-HP – Construction of a rear door with window and replacement of rear window with doors at 10 Lafrowda Terrace, St Just. Applicant Mrs M Foden. The Town Council raised **no objection** to the application.
