4. Nevada & Bendigo Twinning Committee

5. The County of Cornwall(St Just) (Various Streets)(Various Speed Limits))Order 2011

Cornwall Council is inviting comments from the Town Council on a proposal to provide a local nominated new 20 mph speed limit with two 30 mph speed limit buffers. This 20 mph speed limit will reduce vehicle speeds and improve road safety in the vicinity of the local schools.

Attached for members of the Town Council are details of the proposals. The Town Council is asked to submit comments by 16 December 2011.

6. <u>The County of Cornwall (St Just) (Various Streets) (On-Street Parking Places and Restrictions On Waiting) (Consolidation) Order 2006 (Amendment No.2) Order 2011</u>

Following the recent public consultation period on the above proposed Order, Cornwall Council has decided to re-consult on an amended design for South Place, with the inclusion of two disabled parking bays in other areas of St Just.

Cornwall Council is re-inviting comments on the proposal to provide local member nominated new no waiting at any time restrictions on South Place, St Just. The amendment will create a chicane in parking which will further reduce vehicular speeds and also protect the junction of South Place Gardens.

Attached for members of the Town Council are details of the proposals. The Town Council is asked to submit comments by 16 December 2011.

7. Cornwall Council (Off Street Parking Places) Order 2012

Cornwall Council is currently consulting on a new parking order for Cornwall because Cornwall Council is proposing new car park charges across the county.

The proposed charge rates have been set after consideration of local requirements as expressed by the Cornwall Councillors of the local Community Networks. Changes to the charges in each car park vary but have been designed to provide a 3% increase on the total income.

Details of the charges being proposed for the Lafrowda Car Park, St Just and St John's Terrace, Pendeen are set out in the consultation documents which can be accessed on the Cornwall Council website. Details have also been displayed at the car parks.

The Town Council is asked to submit comments by 16 December 2011. This consultation is separate to the discussions that the Town Council is currently having with Cornwall Council on the devolution of the car parks to the Town Council.
