## TC.230 <u>DECLARATIONS OF INTERESTS</u>

## TC.232 MINUTES

<u>RESOLVED</u>: That the minutes of the Ordinary Meeting of the Town Council held on 18 November 2013 be approved as an accurate record and signed by the Town Mayor.

## TC. 233 MATTERS ARISING

On minute no. TC.217/13 (Matters Arising), the Town Clerk reported that she had now received confirmation from Cornwall Council's Environmental Health Service that regarding the fish waste disposal at Brea Vean Farm, the landowner did have a licence from the Environment Agency. The landowner was carrying out drainage work in the field and the shells were being used as gravel around the pipes. Therefore, no statutory nuisance had been witnessed and no environmental impact from shells.

Councillor Mrs Blundy reported on the commencement of the consultation on Poltair Hospital and that she would be attending a meeting at St John's Hall, Penzance on 11 December 2013.

In respect of Minute No. TC.221/13 (Neighbourhood Planning) the Town Clerk also reported that former Town Councillor Sandy Angove had agreed to help with the review of the Community Action Plan 2025 document and that the first meeting was due to be held on 6 December 2013.

### TC.234 COUNCIL BUDGET & PRECEPT 2014 / 15

The Town Clerk, assisted by Dave Stevens presented an amended report which gave details on a proposed budget and level of precept for 2014 / 2015 (copy appended to the signed minutes). The Town Council was reminded that it had previously approved a substantial increase in its expenditure to cover the anticipated freehold purchase of the car parks and public conveniences in St Just and Pendeen, and the proposed budget for 2014 / 15 again included financial provision to cover increased expenditure, and continued financial provision for the possible freehold purchase of the public car parks and conveniences in St Just and Pendeen on which discussions were continuing with Cornwall Council. The report recommended that until the purchase took place, the under spend be transferred to a new ear marked reserve entitled "Capital Asset Transfer".

In addition, the Council was also advised that the proposed precept demand to Cornwall Council was based on the Town Council reducing its precept demand by the amount of assumed Council Tax Support Grant which had been assumed to be the same as last year £21,858. Subsequently, the report had been amended following confirmation from Cornwall Council on the level of Council Tax Support Grant to be paid in 2014 / 15.

The budget also proposed increases in the amount available for General Grants and Public Amenity to offset further reductions in grants and services by Cornwall Council.

The report set out the assumptions made in respect of each of the proposed financial allocations to assist the Town Council in reaching its decision on next year's budget and these were unanimously approved by the Town Council.

The Town Council also considered a request from Bosavern Community Farm to pass on the £4,103 allocated in earmarked reserves for allotments to the farm to enable it to provide a new access and to create a position for a farm apprentice.

### **RESOLVED: That**

- (a) the proposed budget for the financial year 2014 / 2015 of £148,600 is approved and that a precept request of £128,462 is made to Cornwall Council by 31 December 2013;
- (b) the under spends in the financial provision for car parks and public conveniences be transferred to ear marked reserves from 2013 / 14 and subsequent financial years for the duration of the Memorandum of Understanding between the Council and Cornwall Council;
- (c) ear marked reserves be renamed Capital Asset Reserves; and
- (d) the remaining £4,134 in ear marked reserves in respect of allotments is transferred to the Capital Assets Reserve.
