An apology for absence was received from Councillor Goninan.

TC.243 MINUTES

<u>RESOLVED</u>:-That the Minutes of the meeting of the Town Council held on 22 February 2010 be approved as an accurate record and signed by the Mayor.

TC.244 DECLARATIONS OF INTERESTS

Councillor Ms P S Angove declared a personal interest in minute no. TC.250 St Just in Bloom as a member of the West Cornwall Local Action Group.

Councillor B F Angwin declared a prejudicial interest in minute number TC.258 (a) Appraisal of Potential Rural Exception Sites for Local Needs Affordable Housing as a relative of one of the landowners of one of the sites identified and agreed to withdraw from the meeting for consideration of the item.

Councillor K McFadden declared a prejudicial interest in minute number TC.258 (a) Appraisal of Potential Rural Exception Sites for Local Needs Affordable Housing as a landowner of one of the sites identified and agreed to withdraw from the meeting for consideration of the item.

TC.245 ALLOTMENTS

Councillor Stevens reminded the Town Council that there were currently two allotment schemes being progressed. One at Bosavern Farm and the other at Kenidjack valley with the aid of the National Trust, both of which were progressing well. Councillor Stevens had received a sample lease agreement for the 10 year lease of the land at Bosavern Farm which he was currently discussing with the land agent. A meeting was also being arranged with a representative from highways to discuss issues relating to the access to the site and the hedge. A hedger had been identified to carry out the work to improve the visibility splay and quotations were being obtained for the provision of a hard standing and water supply on the site.

He advised the Town Council that Cornwall Council was concerned about the impact of individual sheds on the AONB and discussions were continuing on this aspect. A fallback position might be for eight larger sheds to be provided on the site which would be shared by five allotment holders.

The Town Council had already allocated £12,000 in its budget towards the cost of the allotment and an application would be made to the West Cornwall Local Action Group (WCLAG) to bridge the funding gap.

Lindsey Butterfield, National Trust explained that the Trust had been approached by the St Just Area Growers' Association to provide additional allotments. The Trust had identified additional land at Kenidjack valley, a south facing field, located just below the sewage works. The land was currently tenanted but the ESA had agreed in principle for the land to be used for allotments. However, the Trust was also concerned about the siting of sheds and their impact on the AONB. Up to 20 additional allotments could be provided and a grant application for £5,000 was being made towards the cost of fencing, providing water butts, gates, etc a decision was awaited. Ms Butterfield commented that it might be necessary to approach the Town Council for some additional funding if the funding application was not met in full. An element of the funding application required the provision of community activities / events. It was hoped that events held at the Count House would cover this aspect of the eligibility criteria and Councillor Stevens reported that all the local schools had shown an interest in the Bosavern Farm Project.

The Town Council expressed its thanks to Councillor Stevens and Ms Butterfield on the progress made in respect of both allotment schemes and confirmed that it would be willing to consider a request for additional funding if it was required.

<u>RESOLVED</u>: That the progress made in respect of the delivery of allotments at Bosavern Farm and Kenidjack valley, St Just be noted.

TC.246 THE FOULING BY DOGS (CORNWALL) ORDER, 01/2010 AND THE DOGS ON LEADS BY DIRECTION (CORNWALL) ORDER, 01/2010

As part of the consultation process, Cornwall Council was consulting the town and parish councils on the two proposed new orders which had been made under Part 6 Clean Neighbourhoods and Environment Act 2005.

TC.248 CORNWALL COUNCIL'S AFFORDABLE HOMES PROJECT

The Town Council considered the detail of the planning brief in respect of Moorland Close, Pendeen. The Town Council on 22 February 2010 had previously agreed to "support in principle" the development of affordable homes on the site, (min. No TC.229/10 refers) and the document now before the Council sought its comments on the detail of the scheme.

The Town Council commented that in general terms it supported the scheme as described in the planning brief but was seriously concerned about the proposed local connection policy as set out in Appendix A to the document. Members of the Town Council commented that similar concerns had been raised by Sennen Parish Council in respect of the development of affordable homes in its parish and a new policy was being produced to reflect the parish's local needs.

RESOLVED: That

- (1) Cornwall Council be informed that the Town Council supports the scheme as described in the planning brief but that it has serious reservations about the definition of "local area connection"; and
- (2) the Town Clerk is asked to contact the clerk to Sennen Parish Council to seek further information on detail of their local area connection policy and to report back to the next meeting of the Town Council on 2 March 2010.
