## TC.39 MINUTES

<u>RESOLVED</u>: That the minutes of the Ordinary Meeting of the Town Council held on 28 May 2012 be approved as an accurate record and signed by the Town Mayor.

#### TC.40 MATTERS ARISING

In respect of minute no. TC.28/12 (Draft Code of Conduct), the Town Clerk reported that a new interim code of conduct had been produced by Cornwall Council, in consultation with the Cornwall Association of Local Councils, and that it would be brought to the next meeting of the Council on 25 June 2012 for adoption, prior to its implementation on 1 July 2012.

#### TC.41 COMMUNITY LAND TRUST CONFERENCE - LONDON

The Town Mayor gave a report on her attendance at the Community Land Trust Conference on 22 May 2012 relating to issues of interest to the Town Council.

The main focus of discussion had centred on neighbourhood planning which empowered local communities and reduced discretion of the local authority, for which it was hoped further funding would be made available for a second wave of testing. Other topics discussed include the new concept of:

- "Right to Bid" which offered local communities the opportunity to bid to take over responsibility for land and buildings which were of local importance, whether in public or private ownership.
- "Right to Challenge" enabled other organisations to challenge local authorities if they believed they could provide services more efficiently, with the exception of the health service. When activated it prompted a procurement process exercise.
- "Right to Build" which gave local councils the right to build, with community support. The conference view was that this offered little more than community land trusts.
- There would be new income streams and practical support to increase the availability of housing. A new homes bonus scheme would be established which allocated money to local authorities to help increase their housing stock, based on Council Tax receipts which was hoped would bring existing empty homes into use. Local councils would be expected to consult their local communities on how the funding was used. There was a suggestion that the money could be used to fund new neighbourhood plans.
- There would also be a new Community Infrastructure Levy to replace S.106
  Agreement off site payments. This would be a charge on new developments to
  be spent on new infrastructure. The Town Council was advised that Cornwall
  Council had not, as yet opted into the scheme but it was anticipated that 70% of
  all local authorities would have done so by 2016.

#### TC.42 <u>COMMUNICATIONS</u>

Councillor McClary sought the Town Council's support to the development of a new Council forum in its website to increase engagement with the local community on important issues.

As communication was an important element in achieving Quality Council status, the Town Council

The new bill would give local councils the right to appeal against the granting of planning permission in cases where the local council had advised against acceptance.
