MINUTES of the ORDINARY TOWN MEETING of ST JUST-IN-PENWITH TOWN COUNCIL held in the Council Chamber, Council Offices, 1 Chapel Street, St Just on Monday 12 September 2011 at 7.15 p.m.

PUBLIC PARTICIPATION

Richard Pearce, South Place, St Just was not in attendance, and therefore did not address the Town Council on the proposed Traffic Regulation Orders.

APOLOGIES FOR ABSENCE

None received.

TC.81 DECLARATIONS OF INTERESTS

Councillors McClary, K McFadden and N McFadden stated that in respect of minute no. TC.83/11 (Lafrowda and Pendeen Car Parks), they would not be voting on the issue as they had pre-determined their position as they had publically stated that they were opposed to the introduction of car parking charges.

Councillors K and N McFadden declared a prejudicial interest in minute no. TC. 101/11 (St Just Football Club – Provision of Car Parking) as a local contractor who had supplied an estimate for the works, and as relative to the contractor. They both agreed to withdraw from the meeting for consideration of the item.

Councillor F Morris declared a prejudicial interest in minute no. TC.96(a)/11 (Application for Financial Assistance) as a Committee member of the St Just Cricket Club, and agreed to withdraw from the meeting for consideration of the item.

TC.82 MINUTES

<u>RESOLVED</u>: That the minutes of the Ordinary Meeting of the Town Council held on 25 July, and the Extraordinary Meetings held on 15 and 22 August 2011 be approved as a correct record and signed by the Town Mayor.

TC.83 LAFROWDA AND PENDEEN CAR PARKS

Councillor Andrew Wallis, Peter Moore and Scott Sharples, Cornwall Council attended the meeting to update the Town Council on the progress which had been made since the public meeting on 1 September regarding the possible introduction of car parking charges at Lafrowda and Pendeen Car Parks.

Peter Moore gave a summary of the process and confirmed that the Parking Panel at its meeting on 15 September would be formalising its recommendations to the Cabinet meeting in October. This would be followed by a period of public consultation on the Cabinet's final recommendations.

Peter Moore acknowledged that the consensus at the public meeting had been against the introduction of charging at the car parks, and that the potential for the Town Council taking over responsibility for them be investigated. Therefore, the Parking Panel at its meeting on 15 October would be recommended to approve that no action be taken in respect of the Lafrowda and Pendeen Car Parks for a period of 12 months, to enable discussions with Town Council to commence on it taking over responsibility for maintaining them.

The Town Council would now be required to enter into formal discussions with Cornwall Council, and to produce a business plan to demonstrate its financial ability to take on the service. It was important that this information was provided as a matter of urgency as the Council would be setting its precept for 2102 / 2013 in December.

A number of Town Councillor commented that accurate financial information was required from Cornwall Council to enable it to put together a strong business case. Scott Sharples confirmed that the Devolution Team would work closely with the Town Council in its development of a business plan for the car parks and other issues that may come forward over the next few months.

Andrew Wallis confirmed that as Chair of the Parking Panel he was happy to recommend the deferment, and commented that the £11,000 annual running costs of the car parks represented approximately 20% of the Town Council's current budget, and that the resolution of the panel would be for the Town Council to engage with the Devolution Team with a view to transferring the car parks to the Town Council.

It was confirmed that the bus stop and other amenities located in the car parks would not form part of the discussions.

Subject to the Car Parking Panel approving the recommendation, Cornwall Council would be in contact with the Town Council regarding the next stage of the process.

The Town Council supported the progress which had been made so far, and agreed that the Staffing & Premises Committee would oversee the work, and make recommendations to the full Council at the appropriate stages.

TC.84 THE COUNTY OF CORNWALL (ST JUST) (VARIOUS STREETS) (ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING) (CONSOLIDATION) ORDER 2006 (AMENDMENT NO.2) ORDER 2011

The Town Council considered the above amendment order which sought to introduce new no waiting at any time restrictions and a limited waiting restriction on the following streets: South Place, West Place, Regent Terrace and Carnyorth.

It also proposed to reduce the length of the limited waiting bay on Carn Bosavern, replacing it with no waiting at any time restrictions.

<u>RESOLVED</u>: That the following comments be approved for submission to Cornwall Council as part of the consultation process:-

South Place – extend the introduction of double yellow lining to the end of 21 - 23 South Place. Consider the introduction of "Sleeping Policemen" to reduce the speed of traffic on this road if no waiting restrictions introduced.

Regent Terrace – Installation of chicane type yellow lining not consistent with the yellow lining proposed for South Place. The Town Council would prefer to see a consistent approach adopted for both streets.

The 12 additional off street car parking spaces for residents to be provided at the St Just Football Club insufficient to accommodate to displaced vehicles.

Carnyorth Corner - Yellow lining to be extended to the corner on both sides of the road.

Carn Bosavern – Three car parking spaces to be removed.

TC.85 TO COUNTY OF CORNWALL (A3071 AND A3306) (VARIOUS SPEED LIMITS) (AMENDMENT AND REVOCATION) ORDER 2011

The Town Council considered proposals in respect of the B3066 for the introduction of a 40 mph speed limit between the A3071 at St Just and Kelynack, together with appropriate Traffic Regulation Orders and upgraded signing.

The Town Council also considered proposals for the introduction of a 50 mph limit on the A3071.

<u>RESOLVED</u>: That Cornwall Council is advised that the Town Council supports the proposals in respect of the B3066, but does support the introduction of a lower limit on the A3071 as it was unlikely that the lower level would reduce traffic speed on the road.

TC.86 REVISION OF THE LOCAL VALIDATION LIST - CORNWALL COUNCIL

The Town Council considered a proposed new validation list for householder and tree preservation planning applications which had been issued by Cornwall Council.

The Town Council noted the amendments made to the lists but made no additional comments.

TC.87 COUNCILLOR REQUEST FOR ITEM TO BE PLACED ON THE AGENDA

Give and Take Event

Councillor Angove suggested that the Town Council look into the possibility of holding a "Give and Take" event, similar to the one held at St John's Hall.

It was agreed that Councillor Angove would provide the Town Clerk with contact details, and that the Town Clerk would report to a future meeting of the Town Council with further details.

TC.88 PROPOSAL TO EMPOWER LOCAL COUNCILS

The Town Council considered a request for support from the Suffolk Association of Local Councils to a resolution that had been agreed Leiston–cum-Sizewell Town Council on 7 June 2011, and submitted to the Government under the Sustainable Communities Act.

<u>RESOLVED</u>: That the Town Council supports the resolution agreed by Leiston-cum-Sizewell Town Council as follows:-

The proposal seeks new planning guidance on major developers urging them, as a matter of planning procedure to :-

- "(i) Attend a local council meeting to answer questions about their planning application, if the local council wishes, and to
- (ii) Provide resources, if the local council wishes, to enable the local council to assess developer's applications which may be over 1,000 pages long based on a professional critique of the developer's evidence."

TC.89 PUBLIC CONVENIENCES REVIEW

The Deputy Mayor advised the Town Council that a meeting had been held with Paul Martin and Richard Hancock, Cornwall Council to discuss the future provision of public conveniences across Cornwall.

The Town Council was advised that Cornwall Council had to make a 50% reduction in its public conveniences budget for the 2012 / 2013 financial year, thereby reducing its current budget from £3m to £1.5m.

In view of this, Cornwall Council had taken the decision to close it public toilets or offer them to town and parish council to maintain. The subsequent saving in budget would be used to offer grant funding to those town / parish councils which

expressed an interest in maintaining the service. The grant funding which was anticipated to be in the region of 50% of the total annual cost of providing the service, would be available for two years, after which the Town Council would have to meet the full cost.

The Deputy Mayor reported that the annual cost of maintaining the toilets at St Just was £9,083 and Pendeen £8,092, of which 50% represented cleaning costs. It was anticipated that the cleaning costs could be reduced if a local contractor was engaged to carry out the work. The public toilets at Cape Cornwall were owned by the National Trust and not part of these discussions.

Cornwall Council was seeking "in principle" agreements from town and parish councils to taking on responsibility for maintaining the toilets.

Town Councillors felt that the service could be provided more cheaply at a local level, but were concerned at the cost to the Town Council, and additional costs such as vandalism. Scott Sharples, Cornwall Council acknowledged that vandalism was a problem but that on the whole it was more beneficial to the county to keep as many public toilets open as possible.

It was also noted that the Town Council had concerns about the future delivery of public services, and the ability of town and parish councils to be able to take on board these services without adequate financial provision.

Following discussion of the issues raised the Town Council

RESOLVED:

- (1) To support "in principle" taking on responsibility for the public toilets at St Just and Pendeen, subject to further detailed discussions with Cornwall Council regarding funding; and
- (2) That the issue be referred to the Staffing & Premises Committee for further consideration.

TC.90 PLEN-AN-GWARRY

The Town Council noted the contents of the report on the completion of the repairs works to the Plen-an-Gwarry for submission to English Heritage and Cornwall Council.

TC.91 QUALITY COUNCIL STATUS

The Deputy Mayor reported on the required elements that the Town Council had to meet in order to obtain "Quality Council" accreditation.

One of the areas that the needed to addressed was the way in which the Council communicated with its local community. Possible mediums included better use of the Council's website, preparation of a local newsletter and article in the Cornishman.

It was agreed that the issue of communications would be placed on the agenda for the next Town Council meeting.

TC.94 PLEN PROJECT

The Town Council agreed to write a letter in support of the Plen Project's application to the West Cornwall LAG for funding towards its project for a new purpose built backstage and archive facility.

TC.96 FINANCE

Councillor Morris declared a prejudicial interest in this item as a Committee member of the St Just Cricket Club and withdrew from the meeting for its consideration.

The Town Council considered a request for financial assistance from the St Just Cricket Club in respect of travel and accommodation expenses as the club has won its way through to the National Semi Finals of the Barbados 20 / 20 Cricket Competition.

The Town Clerk reminded the Council that it could not make payments retrospectively and that if it was minded to make a financial contribution it must be towards planned expenditure.

<u>RESOLVED</u>: That a S.137 donation of £650.00 is made to the St Just Cricket Club towards travelling and accommodation expenses for the competition in Essex.
