### TC.13 <u>Co-option of Town Councillors</u>

The Town Council considered the issue of the co-option of additional Town Councillors following the uncontested Town Council election on 2 May 2013 which returned only nine Town Councillors to the 12 seat Council.

The Town Clerk advised that the Council had two option:-

- a) To seek nominations for co-option to fill the remaining seats; or
- b) Continue with nine Councillors in the short term as the Council was quorate (one third of the full number of seats (4)). Consideration could also be given to a review of the number of seats being carried out by the Monitoring Officer with a view to reducing the number of seats on the Town Council in view of the difficulty of filling seats at election.

<u>RESOLVED</u>: That the co-option of additional Town Councillors be postponed for a period of up to six months as part of a "settling in" period for the new Town Council.

The Town Clerk advised the Town Council that Sally Newby, the local Community Network Manager had taken voluntary redundancy from Cornwall Council with effect from 28 June 2013. Chantelle Randall would be the new Community Network Manager covering the two Hayle/St. Ives and West Penwith Community Network areas.
