PUBLIC ADDRESS AT COUNCIL MEETINGS

lan Marsh and Helen Turner, National Trust addressed the Council regarding Planning Application No. PA11/01924 regarding the siting of a kiosk and catering trailer at Levant Mine. TC.334 <u>REPORT OF THE TOWN MAYOR, DEPUTY MAYOR AND TOWN</u> COUNCILLORS

The Town Mayor reported that he had attended the St. Ives Civic Service on 17 April. The Mayor had also attended a meeting on 21st April with Adam Birchall, Councillor John Dyer and Chris Goninan, Cornwall Council regarding Bosavern Farm and on the same day met with the Officers from the National; Trust regarding the terms of the lease for the allotments at Kenidjack Valley.

TC.335 REPORT OF CORNWALL COUNCILLOR

Cornwall Councillor Chris Goninan reported as follows:

Geevor

Tamsin Daniel, Cornwall Council would be the new officer linked to Geevor.

Highways

Concerns had been raised about the loss of the finger sign opposite the cricket field directing people to Cape Cornwall and Carn Gloose. Cornwall Council's Highways service had been advised

A meeting had been held with Mike Peters and Andy Cresswell, Cornwall Council and local residents to discuss speeding issues in Truthwall. The installation of a speed visor for that area had proved too expensive. Councillor Goninan was also looking at a priority scheme from the Botallack end.

Carn Bosavern Farm

Councillor Goninan had a meeting at the farm on 21 April with Adam Birchall, Cornwall Council and Councillor John Dyer, Champion for County Farms, together with representatives of the Land's End Peninsula Community Land Trust. This concerned the new Head of Terms for Bosavern Community Farm. A number of important points were clarified and a new tenancy would be sent for agreement and signing in the next few days.

Also on 21st April Councillor Goninan had attended a meeting with the Town Mayor, representatives from Cornwall Council regarding the project for allotments at Carn Bosavern.
