TC.285 MATTERS ARISING

In respect of min no. TC270/15 (Matters Arising), the Town Mayor apologised that he had been unable to attend the Planning West Areas Sub Committee to speak against planning application PA14/08512 (Nineveh Farm, Trewellard). Cllr Mrs James reported that unfortunately the Sub-Committee had approved, with conditions that the building could only be used for family members and not fee paying guests. Therefore, it could not be used as a holiday let.

Regarding min no. TC.276/15 (Application), Cllr Mrs James reported that a site meeting had been held in connection with application PA15/00533 (10, Foundry Close, Tregeseal) which had been attended by Cllr Morris. Unfortunately, it was unlikely that there was insufficient planning grounds to refuse the application and therefore the recommendation would be to approve. The Town Council wished it recorded that it maintained its objection to the application but accepted that it was unlikely that the application would be "called in".

TC.287 MARKET SQUARE SIGNAGE

The Town Mayor advised the Town Council of proposals for the installation of a new surgery sign on the finger post in Market Square, St Just.

The Mayor explained that the sign had been requested by former Cornwall Councillor Chris Goninan in December 2012.

The Town Council expressed its concern that it had not been consulted by Cornwall Council on the new signage, particularly in view of its previous comments regarding the "informal understanding in the community against the proliferation of commercial signage".

The Town Council confirmed that Cornwall Council is advised that it wishes poll cards to be issued to every eligible elector.

TC.291 MATTERS FOR REPORT

The Town Mayor reported that in view of the increasing problem of dog fouling in the Plain-an-Gwarry he had taken the decision to erect a sign on the Council's behalf at the entrance to the Plain advising that the problem was under surveillance and that the Council would take appropriate action if the problem persisted. The Council would continue to liaise with the Cornwall Council's Dog Officer to monitor the situation.

Cllr Mrs Blundy reported that she had attended the AGM od West Cornwall HealthWatch which had discussed the issue of privatisation. Cllr Mrs Blundy also reported that Penwith Dementia Action Alliance was still continuing. Finally, Cllr Mrs Blundy reported that a symphony orchestra from Nevada would be visiting in June 2015. Further details would follow.

Cllr Clemens reported on the problem of all day parking in Market Square. The Town Council asked Cllr Clemens to speak to the owners of the vehicles concerned before any further action was taken.

Cllr Mrs Cock reported that she had met the new Head Teacher of Pendeen School.
