## TC.232 MATTERS ARISING

There were no matters arising from the minutes.

#### TC.233 ST JUST – COACH DROP OFF

The Town Council was advised of a proposal by Cllr Sue James to provide coach drop off points within St Just to increase visitor numbers to the town. There were currently two options being proposed: the first to pilot coach parking at the Rugby Club for which there would be no cost. The second to provide two coach parking bays at the bus station in St Just for which there would be a cost of £600.00 to provide the road markings. To keep costs to a minimum is was being proposed that the works be undertaken without the need for a Traffic Regulation Order which meant that restricting parking in the bays by other vehicles would be unenforceable. In addition, there would be a need for new road signage and some local businesses had expressed an interest in sponsoring signs.

The total estimated cost of the works was £1,000 and Cllr Mrs James was seeking the Town Council's "in principle" support and whether the Town Council would be willing to help fund the proposal.

The Town Council was concerned about a further increase in the number of signs within the town centre and some Town Councillors questioned whether there would be a significant increase in the volume of visitor numbers to the town in the light of the new gallery being opened. However, in order to undertake the pilot the Town Council:-

<u>RESOLVED:</u> To make a financial contribution of £100.00 towards the cost of marking out one coach "drop off" bay at the Bus Station provided that the necessary match funding was secured.

#### TC.234 WEED SPRAYING AGREEMENT

The Town Council considered the detail of a proposed agreement between the Town Council and Cormac Ltd to undertake highway weed spraying within the parish. Due to budgetary pressures, Cornwall Council was once again not funding weed spraying in 2015 / 16 and the offer was now being made to the Town Council by Cormac Ltd to undertake the service at a cost of £2052.00 plus VAT for a distance of 13.68km within St Just, Pendeen and Trewellard.

### **RESOLVED**: That

- (1) the agreement between the Town Council and Cormac Ltd for weed spraying services in 2015 / 16 at a cost of £2,052 plus VAT be accepted;
- (2) the funding for the work be met from the Town Council's "free reserves"; and
- (3) the Town Clerk be authorised to sign the agreement on behalf of the Town Council.

### TC.235 LOCAL MAINTENANCE PARTNERSHIP 2015 / 16

The Town Clerk reported that the grant offer in respect of the Local Maintenance Partnership (LMP) 2015 / 16 had been received from Cormac Ltd on behalf of cutting the public rights of way in the parish. The Town Clerk reported that the amount of grant had remained unchanged from previous years £5,636.00. The Town Clerk also sought the Town Council's approval to continuing with Scottworthy Estate Services as the Council's approved contractor in 2015 / 16 and that Standing Orders be waived accordingly.

## **RESOLVED**: That

- (1) the grant of £5,636.00 in respect of the LMP 2015 be accepted; and
- (2) Scottworthy Estate Services be retained as the Town Council's preferred contractor for 2015 / 16 and that standing order 19(c) and financial regulation no 11 be waived accordingly.

Cllr Mrs James also reported that all residents had received a visit from the local Police to allay concerns about personal safety.

Cllr D Roberts reported that the St Just Sports Hall was continuing in its development of new activities to increase usage of the facility. A new "Tumble for Toddlers" activity had been introduced.

Cllr G Roberts reported that Pengarth Day Centre had secured £7,165 of grant funding towards its transport costs and an additional grant of £36,000. Cllr Roberts was due to attend a Board of Trustees meeting on 16 January 2015.

Cllr Mrs James also reported that the keys to the new properties at Moorland Close had now been handed over to the Land's End Peninsula Community Land Trust. An open event was being held on 17 and 31 January 2015 between 11.00 a.m. and 2.00 p.m. to which all Town Councillors were invited to attend.
