## TC.193 APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllr N McFadden and Cllr Mrs James.

## TC.194 DECLARATIONS OF INTERESTS

The Town Mayor and T McFadden declared a non-registerable interest in minute no. TC.200/16 (Applications) in respect of planning application PA16/09222 as the applicant and related to the applicant and agreed to withdraw from the meeting for consideration of the application.

The Town Mayor and T McFadden also declared a non-registerable interest in minute no. TC.199/16 (Accounts for Payment) as they were related to a payee on the schedule and agreed to withdraw from the meeting for consideration of the application.

Cllr G Roberts declared a non-registerable interest in minute no. TC.200/16 (Applications) in respect of planning application PA16/09475 as a tenant on the site.

# TC.195 <u>DISPENSATIONS</u>

## TC.196 MINUTES

<u>RESOLVED</u>: That the minutes of the Ordinary Meeting of the Town Council held on 28 November 2016 be approved as an accurate record and signed by the Town Mayor.

#### TC.197 MATTERS ARISING

On minute TC.183/16 (Local Council Pre-Application Protocol), The Town Clerk reported that she had received a response from Sarah Mason, Executive Officer, CALC which had confirmed that the protocol aimed to set a standard for dealing with preapplications and that there was no limit to the scale of development; although a local council could set its own minimum threshold for engagement.

In response a further question from Cllr Mrs Blundy, the Town Mayor reported that he had, not as yet, approached Mr Woolcock about the repositioning of the defibrillator on the Commercial Hotel. The Town Clerk also reported that the external defibrillator had been temporarily decommissioned due to the ingress of moisture which could affect the equipment and that the Ambulance Service had been notified.

## TC.198 COUNCIL BUDGET & PRECEPT 2016 / 2017

The Town Clerk, assisted by the Deputy Mayor presented a report which gave details on a proposed budget and level of precept for 2017 / 2018 (copy appended to the signed minutes).

The report outlined the challenges facing the Town Council in the light of further budget cuts by Cornwall Council and continuing discussions on the further devolution of services, such as future management options for the library in St Just, open play spaces, car parks and public conveniences.

The Town Council was advised that as in the previous two years, the Town Council would receive Council Tax Support Grant in addition to the precept demand, and therefore the Town Council would be reducing its precept demand by the amount of grant it received. On advice from Cornwall Council the level of grant in 2017 / 2018 would be £9,376.69 a reduction on last year's figure.

It was also likely that there would be further reductions to Cornwall Council's Environment Service and this had been recognised in the proposed increase in the financial provision for Public Amenity as the completion of the transfer of title for Pendeen Playing Field to the Town Council was now likely to be completed in the early part of 2017.

The Town Council was also presented with figures on the freehold valuation of the current building, together with various leasehold options in view of the fact that the Council's current lease expired in September 2017. The Town Council also received details on the valuation of the Lafrowda Car Park, which would include the recycling facility, street lighting and bus shelter and stops, together with a transfer of the public toilets which were located in the car parks.

The valuations were as follows: -

- Council Offices freehold valuation £165,000
- Council Offices Leasehold) whole building) £14,000. £6 7,000 for the existing ground floor area.
- Lafrowda Car Park £100,000

The report set out the assumptions made in respect of each of the proposed financial allocations to assist the Town Council in reaching its decision on next year's budget and these were unanimously approved by the Town Council.

#### **RESOLVED**: -That

- (a) the proposed budget for the financial year 2017 / 2018 of £154,200 is approved and that a precept request of £138,823 is made to Cornwall Council by 31 December 2016; and
- (b) £20,000 be transferred to the "Capital Asset Reserve" and that the remainder £9,091 be allocated to the "Free Reserve"; and
- (c) the Town Mayor, Deputy Town Mayor and Town Clerk be authorised to represent the Town Council in further discussions with Cornwall Council on the freehold options in respect of the Council building, car parks and public conveniences and to report back to the full Council.
