(a) Applications

PA16/02426 New front entrance lobby and store at Mariner's Cottage and rear sunroom extension across the rear of Mariners and Crown Mines Cottages, at Mariner's Cottage (8 Botallack) and Crown Mines Cottage (9 Botallack). Applicant: Mr. Bill Keillor. (T. Cl. Strong Objection – The Sun Room not in keeping as it is not fully glazed and therefore it obscures the view of the facade of the original building. Also considered to be wrong use of materials on the south facing side (Too modern). No Objection to the highway side.

PA16/02219 Proposed new vehicle access by creating an entrance from the main highway (B.3306) into the farm with the aim of improving visitors' safety, particularly when leaving the site at Bosavern Community Farm, B.3306, Bosavern, St. Just. Applicant: Mr. Robert Pickering, Bosavern Community Enterprises Ltd. (T. Cl. Strong Objection – Entrance needs to be flared in for safety reasons so that traffic can be viewed easily in both directions. Lowering the hedges does not solve this problem. Also, T.
