TC.101 APOLOGIES FOR ABSENCE

There were no apologies for absence

TC.102 <u>DECLARATIONS OF INTERESTS</u>

The Town Mayor, Cllr T McFadden and Cllr D Roberts declared non-registerable interests in respect of minute no. TC.112(a)/16 (Pre-application Advice) in which the applicant was seeking the Town Council's informal view on a potential planning application to extend the industrial site at Carnyorth, and agreed to withdraw from the meeting for consideration of the item.

Cllr N McFadden declared a registerable interest in respect of minute no. TC.112(a)/16 (Pre-application Advice) as the applicant seeking the Council's informal view on a potential planning application to extend Cornwall Garden Services site at Carnyorth, and agreed to withdraw from the meeting for consideration of the item.

Cllr Clemens declared a non-registerable interest in minute no. TC.111(a)/16 (Grant Applications) as a trustee of Pendeen Silver Band which regularly used Pendeen Parish Hall and agreed to withdraw from the meeting for consideration of the item.

Cllr Clemens also declared a non-registerable application in respect of minute no. TC.112(b)/16 (Applications) in respect of PA16/06443 as the applicant was a personal friend and agreed to withdraw from the meeting for consideration of the application.

Cllr D Roberts also declared a non-registerable application in respect of minute no. TC.112(b)/16 (Applications) in respect of PA16/06443 as the applicant was a personal friend and agreed to withdraw from the meeting for consideration of the application.

Cllr Morris declared a non-registerable application in respect of minute no. TC.112(b)/16 (Applications) in respect of PA16/07585 as the applicant was a neighbour and agreed to withdraw from the meeting for consideration of the application.

Cllr Mrs McQueen declared a non-registerable interest in minute no. TC.111(a)/16 (Grant Applications) as the Chairman of Pendeen Parish Hall & Theatre was a personal friend and agreed to withdraw from the meeting for consideration of the item.

TC.103 <u>DISPENSATIONS</u>

TC.104 MINUTES

TC.105 MATTERS ARISING

In respect of minute no. TC.99/16 (Matters for Report), the Town Clerk reported that the issue of unauthorised activity on land at the rear of Leswidden Clay Works had been lodged with Planning Enforcement and that the matter was being investigated.

TC.106 REPORT OF THE TOWN MAYOR, DEPUTY TOWN MAYOR AND TOWN COUNCILLORS

The Town Mayor reported that together with the Deputy Mayor and the Town Clerk he had attended a meeting on 25 August 2016 with officers from Cornwall Council regarding devolution matters.

The Deputy Mayor reported that he attended a reception held by the NCI on 9 September 2016.

TC.107 REPORT OF THE CORNWALL COUNCILLOR

The Town Council received Cllr Mrs James's monthly report of county matters as follows:

Highways matters seemed to be making controversial headlines at the moment: Cllr Mrs James pointed out that many of the larger road schemes were projects that had been many years in the making and had Government and/ or other grant monies attached to them. They were as big a surprise to many of the 2013 intake of Councillors as they had been to the public as they had been approved more than four years ago. However, latest proposals regarding the extension of resident parking permit schemes and the increase in the charges for such schemes was a current and very controversial idea being put forward by the Cabinet but lacking broad councillor support. Proposals would go out for public consultation in the autumn and could see many residents in Penzance and St Ives having to pay as much as £80 a year for street

parking.

Cllr Mrs James had also discovered, through her recent drop-in surgery, that conveyance search requests to the West Land Charges Office were taking longer than usual due to a high level of sickness in the team. She had been advised that results were taking 25 working days to process whereas normally it was 5 to 6 working days.

Finally, Cllr Mrs James had attended the public consultation event concerning the proposed re-establishment of a Heliport in Penzance.

TC.108 TIN COAST PROJECT

The Town Clerk and Cllr N McFadden gave the Council an update on the development of the Tin Coast project and version 5 of the draft Destination Management Plan which had been previously circulated to Councillors via email.

The Town Clerk reported that as significant progress was being made the Council needed to consider becoming a formal partner of the project which would possibly include increasing input into the project.

Cllr N McFadden commented on the progress being made and the significance of the project to the local economy in the medium to long term and stated that it was important that the Town Council became a partner in the project.

Following detailed consideration, the Town Council RESOLVED: That

- (a) the Town Council becomes a formal partner of the project with immediate effect;
- (b) Cllr N McFadden be confirmed as the Town Council's representative on the group; and that Cllr T McFadden be appointed as a substitute member to attend meetings in the absence of Cllr N McFadden; and
- (c) the Council continues to receive regular reports on the development of the project and that all requests for assistance are brought to the full Council for approval.

TC.109 ST JUST & DISTRICT TRUST

The Town Clerk reported that she had recently been advised by the Chair of the St Just & District Trust that the Trust was in the process of becoming a Charitable Incorporated Organisation. As the building had originally been transferred from the Council to the Trust, the Town Clerk advised that she had sought legal advice from Cornwall Council on the possible implications for the Council. The Clerk also referred to a couple of potential issues regarding the cost of transfer back to the Council in the event that the Trust failed and para.3 Objects of the proposed new constitution which stated "activities to include preservation, maintenance.....etc." of the Plain-an-Gwarry which was under the ownership of the Council.

Cornwall Council Legal Services had advised that the change from an unincorporated body to an incorporated body was akin to a change of trustee's. The charity was

continuing but with a new management structure and, as such, the right of preemption might fall away following incorporation as the charity in its incorporated form was not the same legal entity as that entered into with the original transfer. The legal advice was that a separate stand-alone right of pre-emption should be drawn up between the Town Council and the new incorporated Trust. Cost would be in the region of £600 - £800 depending on the negotiations but it would not be unreasonable for the Council to ask the Trust to contribute to the Council's legal costs given the fact that the matter had arisen due to the actions of the Trust.

RESOLVED: That

- (a) Cornwall Council's Legal Services be engaged to act on behalf of the Council to draw up a new stand-alone pre-emption agreement between the Council and the Trust at a cost of between £600.00 £800.00; and
- (b) St Just & District Trust be asked to make a contribution towards the Council's legal costs.

TC.112 PLANNING

(a) <u>Pre-application Advice</u>

In accordance with their disclosures of interest the Town Mayor, N McFadden, T McFadden and D Roberts withdrew from the meeting for consideration of the following item.

In the absence of the Town Mayor, the Deputy Town Mayor took the Chair for the following item.

Liam McFadden, Cornwall Garden Services attended the meeting to seek the Town Council's informal view on a potential planning application to extend its current business site at Carnyorth.

In giving its view the Town Clerk commented that this was an informal opinion and that the Council's formal view would be reserved until such time as it considered a formal planning application.

Mr McFadden explained that it was proposed to extend the current site by approximately half an acre and tabled a plan of the proposed location. The land would be used for additional car parking, there would be a small increase in the workforce to 33 staff and there would be no change to the current exemption / licences on the site. The Council expressed its informal support to the possible expansion of the Carnyorth site in preference to the Leswidden site and commented on the state of the site, improvements to the access by reducing the effect of dust on neighbouring properties and future expansion opportunities.

TC.113 BT TELEPHONE BOX CONSULTATION

The Town Clerk reported that BT was consulting on its current programme of intended public payphone removals and that the payphone at Carnyorth was in the list of removals as it had only been used to make 9 calls within in the last year. Cornwall Council was co-ordinating responses from local councils with a deadline of 28 October 2016. The Town Council decided to make no comment / objection to the proposed removal.
