## TC.182 MATTERS ARISING

Sue James mentioned previously that the Environmental Crime Officers were looking at the issue of abandoned cars as they have more powers to deal with. The latest estimate of abandonments were being looked at was up to 7 could be removed in the future. Sue James also mentioned that PA17/10754 non-material amendment was reported to

Cornwall Council.

## TC.183 First Draft Budget 2018/19

Discussion of draft budget. The clerk informed the council that given the additional expenditure being forecast in the next financial year he would welcome several councillors to go over the assumptions on expenditure before presenting them to the council.

<u>RESOLVED</u>: That the Town Mayor and Geoff Roberts would meet with the clerk on 20 December 2017 to check the assumptions and figures in the draft budget.

## TC.184 <u>Localism/Devolution St Just and Pendeen Car Parks</u>

The mayor updated the council on the fact that despite being told by Cornwall Council in July 2017 the Car parks could be transferred in a matter of weeks, nothing had happened. A summary of situation was outlined. Freehold valuation remains at £100,000. This option would include purchase of the recycling area which would be transferred to the Council subject to a licence in favour of Cornwall Council and its waste contractor to locate recycling bins for all purposes. Bus turning and parking area: Cornwall Council will require this to be part of any transfer. Street lights — Cornwall Council expect these to be transferred with the car park. Finally, the public toilets — All public toilet transfer have been undertaken based on a property transfer for £1 with the town or parish council taking the revenue responsibility without support, grant or offset by any other property transfer. If the Town Council decide to take over responsibility for the public toilets, then they could be included in the transfer but there would be no adjustment in the valuation.

<u>RESOLVED</u>: That the clerk writes to Cornwall Council to make a formal approach and progress the purchase.

## TC.188 NEIGHBOURHOOD PLANNING

James Hardy Community Link Officer and several councillors had a successful meeting on 5 December in St John's Hall, to discuss the next open meeting in January 2018 at Pendeen. Marna Blundy will be working on the communications to interested parties through the Clerk in December with the 105 people who have registered their interest in the process.

The eight councillors with specific neighbourhood planning responsibilities were meeting in a working (advisory) group immediately after this council meeting. This meeting would be used for councillors to plan for January's open public meeting.

Councillors then discussed the need to have funds allocated to cover costs with the Neighbourhood Plan, such as hall hire, printing and associated costs.

<u>RESOLVED:</u> Councillors agreed up to £250 could be used for the Neighbourhood Plan in this financial year.

### **INFORMATION ITEMS**

NHS England Radio Therapy consultations on moving some services from Truro to Devon were extended and the Clerk would submit the council's response to keep services at Truro and write to Derek Thomas MP to let him know we wanted to keep services local to Cornwall.

Marna Blundy reported that The Walking Nativity on Friday 15<sup>th</sup> December was well supported and attended and it is likely to be repeated next year.

The Locum Clerk updated the council on a previous item damage to its property in a road traffic incident in St Just being a waste bin; the police/council are aware of individual responsible and have the incident logged and we await an actual estimate for repair or (replacement likely to be £700).

It was also reported that the Cormac cleaner had left a cleaner's cupboard door unlocked at St Just toilets, which had allowed some damage to be done to that area.

Bev Strick reported that she had been unable to attend the Centre of Pendeen meeting , but that the computers there are in use.

## TC.190 REPORT FROM CORNWALL COUNCILLOR SUE JAMES

Reported on 4 key areas.

## 1. Accountable Care System

This is the proposed means for integrating Health and Social Care and is a Nationally promoted model. In Cornwall, the only people at the table working on this are from the NHS and the Council. Cornwall are not amongst first adopters and there is not one version of this so we have set up a cross party inquiry to take evidence and consider what would work best for Cornwall. Whilst there is much in the media about the end of the NHS, if people want to consider objective reviews and reports I would suggest they turn to the Kings Fund website.

#### 2. CAB Funding

Cornwall Council are committed to finding a solution to this problem despite severe budget pressures and our struggle to find what we can agree to cut to balance the budget. The situation has arisen because, in the last administration, there was agreement with the CAB that the grant would gradually be removed and this coming year was to be the final step to zero. However, for whatever reason, the CAB are now saying they cannot manage without some grant so we are looking at a combination of maintaining some funding and offering office space, to resolve.

#### 3. Localism

There is a push to make Community Networks the place where local decisions are made by Town, Parish and Cornwall Councillors. This is to enable them to shape places and local services. To support this change, budgets will be given to Networks to agree how to spend in their areas and the first will be funding for local Highways schemes, in 2018/19.

### 4. Penwith Landscape Partnership

We have had confirmation that the Partnership has been awarded £2,529,100 from the Heritage Lottery Fund for the First and Last – Our Living Working Landscape scheme. The project will start in January and last for 5 years and St Just is the town within the area of benefit. An office is being sought and leads are being followed in St Just but they may have to go outside the town, if something cannot be secured quickly.
