(b) Financial Assistance

- **e)** The draft Letter to the local MP on Government Planning Changes was agreed with one minor amendment.
 - **RESOLVED:** To approve the letter to be sent to the MP.
- f) The Council were required to make a Protocol decision on PA20/03290 Goldings Barn, St. Just. This agricultural barn with its complimentary extension will make it look like an agricultural building and will enhance the barn. The Application was considered again by the Town Council.

The Council considered that it would:

- blend into the landscape, with a significant tree planting plan.
- The barn is too small and not viable as a dwelling without an extension.
- Council supports sustainable and energy efficient building in the parish.
- Both CC and the TC have declared a Climate Emergency. The Council is promoting sustainable and energy efficient buildings.

The Clerk is continuing to send emails from the various bodies such as CALC and Cornwall Council to Councillors on advice the Town Council should take. New Government Guidance changes week on week and is sent on to Councillors. The Clerk mentioned he had just received the latest and would be forwarding once he read through it and its many attachments.

TC.64 Cornwall Council Dog Fouling posters.

Cornwall Council is inviting Town and Parish Councils in Cornwall to apply to receive five "We're Watching You" (there is a cost for the posters, but it is a reduced cost) glow in the dark signs to help tackle dog fouling in a notorious site within your community this autumn. The Council needs to have a Community Ambassador who can be either paid or a volunteer. Preferably, the Community Ambassador should not be directly associated with the Council. The strict deadline for application submissions is 17.00pm on Friday 6th November 2020. Two names were suggested and the Mayor and Deputy Mayor would approach them and if agreed give their details to the Clerk. Louise Paine offered to take on the role if no volunteer could be found.

RESOLVED: The Clerk would use the information to submit an application to Cornwall Council.

TC.65 Mayor's Report

Arrangements for Annual Award presentations

I'm pleased to say that I've made arrangements with all the award winners, and presentations will be made to Riley Rivett at Pendeen Primary School in front of his class; to Archie Prout at Cape Cornwall School in front of his year group; to Daisy and Jo from the Daisy Chain at Botallack, together with certificates they will deliver to all 88 community wardens in the scheme; and to Mo O'Brien at Cape Cornwall Surgery with all her colleagues in attendance.

Mayors of Cornwall meeting 15th October 1. Policing

This gave a chance to discuss policing with Jim Pearce, the Temporary Assistant Chief Constable for Devon and Cornwall, as well as Police Commander for Cornwall: I asked about the lack of police response to 101 calls from our area, and we discussed community concerns - the lack of confidence that the police will respond, plus the growing confidence of offenders that they won't be caught. I would value input from Councillors about how we can progress this.

2. Brittany Ferries

There is concern about the long-term future of Brittany Ferries and the impact that its loss would have on Cornwall. Councils are encouraged to write to their MP, and we were given a suggested draft letter, if this is something Council would wish to do.

RESOLVED: The draft letter was agreed and the Clerk would send letter off.

Road Safety at Boscaswell Stores

I attended a site meeting with the Head of Pendeen Primary School, the Nursery Manager, parent representatives, the Manager of Boscaswell Stores, Andy from Highways, and Sue as Cornwall Councillor, following a recent accident involving a pupil, and ongoing concerns about safety at the junction. It was frustrating that every suggestion - whether double yellow lines, deliveries at the side, a zebra crossing, a speed reduction to 20mph, or speed humps - seemed to be ruled out by Highways, and even a crossing patrol volunteer, who could only help twice a day, seemed problematic. I think it's fair to say that most of those present were keen to see some safety measures put in place, and concerned that without action there could be a more serious accident. When you look at the location, a five-way junction, combined with a busy shop, a car park and a bus stop, seems a perfect storm to me. I would welcome Councillors' thoughts on what might work.
