## The Second Quarter Report 1 July – 30 September 22.

The Second quarter report covers 1 July - 30 September 22. The Third quarter report will be due in the end of January 2023.

St Just Town Council opening balance on 1<sup>st</sup> April was £457,627.58.00 (which included £48.89 petty cash and £457,778.69 in the two bank accounts). The Council's budget for 2022/23 is £356,668.00. The spending as at 30 September was £94,103.21. The second quarter does not give any cause for concern and is a better indicator than Quarter 1. We know all expenditure is rising due to the economic downturn and the increase in energy prices.

- Petty Cash is used for very minor items from cleaning products to engraving Mayor's chain.
- National Lottery Budget (Climate Change) Grant was £9891, can only be used for Bid listed items and is on-going.

The Council has also received £47,950.00 in last FY. It is in the bank account and now due to be spent in Quarter 3. The expenditure was to commission consultants to create a final Report and part payment could happen very shortly (tonight).

The Council's 2<sup>nd</sup> instalment of the precept from Cornwall Council was received in September.

#### Note

We will be moving to Octopus from Bulb (government approved) because the previous firm went out of business and Octopus is a growing company with good customer service reputation and has been given Bulb customers.

#### Banking Reconciliation:

To 30<sup>th</sup> September 2022 the bank reconciliation is good and all figures are correct and will be signed off by the two Councillors given this task this week.

# Projects:

We have income streams mentioned such as Town Vitality Fund which will be finalised in Quarter 3.

The Welcome Back Fund

The WBF reimbursement was received/finalised in Quarter 2 and no further actions. The Council has budgeted for different projects over the years and has reserve funds for potential work like Pendeen Playpark and the Plain an Gwarry which will be focused upon once we have completed the Devolution Programme.

#### CIL

The Council received £2,861 CIL funds in May and this was earmarked for Pendeen Playpark work. Last month the final amount £1640.24 for this FY was received. It is hoped the second amount will be used again for Pendeen Playpark if a resolution was made which will ensure £4501.47 of CIL money goes to this project.

**RESOLVED**: To agree the second payment is also reserved for the project at Pendeen.

We have £13,608 left in the Community Grant Budget with £11,392 spent. We have 2 QPJ items totalling £3,718 which should come off the QPJ budget. It may well be an idea to use the remaining budget to go into a King Coronation Fund but that can be decided in budget setting in December/January.

Community Network Highway Scheme. Brian Clemens explained the planned background to this project especially at Pendeen - no physical crossing but a virtual path to improve the safe movement of people and vehicles around the school area. It was requested that the Clerk contact the CLO that the road safety scheme was also a concern for all road users such as pedestrians including (children).

Temporary closure Market Street 5 - 16 December 2022 - Noted no further details were available.

# TC.128 Information Items and Matters to Report

Landscape Character Assessment Event. The Council received an update from two Councillors who attended. They mentioned it was well attended and informative. They had only commented at the event on parish matters.

The update following Feast. It was expressed by many who attended how well the event ran and many people had said it was good to get back the traditional style of the event after the restrictions of Covid.

Miners Chapel. The Mayor is a trustee of the Chapel on behalf of the Council. The Mayor explained the history of the Chapel since 2016 when it faced closure; but had managed to get charity trust status and funds to carry on. The trustees are considering future options.

Remembrance Sunday - Details on the St Just event were circulated before the meeting and the Mayor updated Councillors on what was happening at Pendeen. There is an informal gathering on 11 November 22 just before 11am at the Memorial Clock in St. Just.

Safeguarding training is taking place on 22 November, 2022.

Lands' End Peninsula Community Land Trust have ownership of the new cemetery field in Pendeen.

The Cornwall Councillor mentioned the next Community Network Meeting is on Thursday 17<sup>th</sup> November ,22 and a major review is underway on its work. He also mentioned that Cornwall Council are planning a cash flat budget.

Cornwall Councillor mentioned he had a meeting in St. Just with the Chief Fire Officer.

# TC.129 <u>Devolution Projects</u>

The Town Council were keen to have devolution completed but the toilets were still not in a good and fit working condition to transfer over. Cornwall Council

# TC.130 Climate Change Group

An update from Councillors on CCG following their recent meeting: Discussion on the structure/set up of the CCG took place. The Council needed an internal focus on its own steps to ensure it was working towards the Council's own objectives between now and the AGM in May 2023. The mayor will write up the suggested plan which Councillors agreed for this period. This item will then come back to the next meeting. No further spending by the CCG without full council approval and the CCG situation/Structure will be reviewed the AGM.

#### TC.132 Christmas Tree Lights

Farmer Morris had been doing some pricing with potential purchase of Christmas lights for Pendeen mentioned at the last meeting. The Town Council would need to have comparable lights to match the existing lights to ensure they could be interchangeable. Last year the Council purchased lights for St, Just. Farmer Morris highlighted the most suitable provider and asked the Council to make an order for new lights costing £845.00.

**RESOLUTION**; The Town Council agreed for the order to be made for £845.00 through the Council Office on the exact specification provided.

# TC.133 Christmas Lunch for Staff

It was usual for the Town Council to fund staff to have a Christmas lunch in the parish. The number of staff has increased and it was felt that the cost would be split between the Mayors Fund and the Functions budget. The Mayor said that given the number of staff she would not need to be invited herself.

**RESOLUTION:** The Town Council agreed for the staff to have a staff lunch with funding as above.
