#### TC. 175 Youth Provision Review

## TC.177 Correspondence

The Town Council discussed:

An email from a Pendeen resident with reference to Cornwall Council proposal /consultation reference EDG2138\_SN02, which proposes the introduction of a no waiting at any time restriction on the B3306 from the Spar shop to Pendeen pottery. At the last meeting Cornwall Councillor Brian Clemens explained the planned background to this project at Pendeen - no physical crossing but a virtual path to improve the safe movement of people and vehicles around the school area and other alterations.

The Royal Mail have sealed-off the post-box in Botallack for health and safety reasons. The residents have asked the Council to contact Royal Mail to support its reinstatement or the positioning of one; near the old site.

Two people had reached milestones: Citizen of the year Anton Barnes had achieved 25 years recognised service with St John Ambulance and PCSO Andrew Tonkin 20 years with Devon and Cornwall Police.

King Charles has sent a thank you card and message to the people of St Just-in-Penwith Parish, which will be on display in St Just Library, until the end of February it will also be mentioned in the Mayor's Outreach Magazine item.

Climate Change Committee and the offer of free trees for planting was discussed at the meeting. Councillors will be making contact to see what type of trees are involved.

Robert Chadder praised Doug Luxford for continuing to be a Community Volunteer in going around St Just to pick up the dog mess, and engage with people & try & tackle the issue head on.

The Clerk informed the Council on the progress on work on the War Memorial. Tidying up work on the inscriptions was agreed for £160 and will start in good weather. Other work tasks have contractors preparing estimates.
