## AONB notes

"Uncharacteristic appearance"

These elements combine to provide a marked domestication of the valley bottom which is at odds with its characteristic pattern of small, enclosed **fields** 



descending the steep valley sides to the mix of rougher grazing, scrub and woodland at the valley bottom.

# **WHS Planning**

The pond appears as a somewhat incongruous, domestic addition within this section of the WHS that neither conserve or enhances the rural landscape character of this section of the WHS. A degree of harm to the landscape character occurs that is not outweighed by any significant public benefit.

# **Environment Agency**

In the absence of an acceptable flood risk assessment (FRA) we object to this application. The reason for this position and advice is provided below. At this stage, it would be our view that the proposal fails to comply with the National Planning Policy Framework Chapter 14 or policy 26 of the Cornwall Local Plan

# Lands' End airport

Of particular concern are the reports that Canadian Geese are now present at the site - it is well documented that these species are a hazard to aircraft. The Airport has noted a recent increase in the overflight of such birds.

Until this further detail, survey and assurances are received, the Airport cannot support this application due to the potential effect on aircraft safety.

## CPRE

CPRE Cornwall objects to this retrospective application.

The pond was constructed without planning permission, 2 years ago and is in an Area of Outstanding Natural Beauty and St Just District Cornish Mining World Heritage Site.

The pond is contrary to the Cornwall Local Plan Policy 2 and Policy 23 and does not comply with Cornwall AONB Management Plan, Policy MD9. We cannot assess the ecological impact, the environmental impact, the flood risk, and aviation safety based on the information currently available.

# National trust

We would therefore request that the local planning authority - before determining this application - is satisfied in respect also to the following material considerations:

That any future water abstraction to maintain the pond does and will not present problems to aquatic life in the river downstream, and that any pollution, including any increased nutrients, entering the river through whatever means due to the creation and retention of the pond, does and will not present problems to the natural environment downstream.

The Trust is supportive of nature enhancements where they are in the right place and provide for biodiversity net gain. We however are not presently convinced, on the basis of what has been submitted and paying regard to the several consultee responses received to this application, that this development



in the round is appropriate and provides the necessary ecological mitigation and enhancements.

# Ecology;

On the application form:

There is a tick box for the applicant to complete for

"Protected and priority species "

"on the development site, on land adjacent to or near the proposed development "

The applicant's agent Answered "No "

This is not true.

There is an active badger set on the opposite side of the stream.

**Preliminary ecological appraisal** of the site (applicants paid consultant) No invertebrate survey was completed.

There has been no survey of land adjacent (or "near to ") included in the documents.

(Excerpts from that ecological appraisal)

# **Running water**

5.1.2. During construction there would have been the potential for the release of sediments into the stream, due to run off from the freshly bare

soil. (There are now cattle walking on the raised bank)

5.1.3. Once dug the main potential impact is the use of water from the stream in maintaining the water level of the pond. (How will the pond fill in future?) A channel had been dug between the stream and the pond, but this had been closed off by the time of the October 2021 visit. (This constitutes abstraction for which permission is needed)

## My comments;

The pond is not naturally viable. It has been stated that it will be filled by natural "run off "and spring water. the pond has been dry since it was drained and there has been no evidence of the water source claimed.

The "potential impact "of using water from the stream has been noted in the client's own ecology assessment. No ecology survey has taken place on surrounding habitat including the stream below the pond where damage may have already been done. As an example, the pond was filled in May and water abstracted from the stream, which is at a time when Elvers would be likely to be migrating upstream if the water flow was suitable. At the time the stream was dammed and its flow further downstream seriously compromised by this. It has also been noted that sediments could be released into the stream which can cause damage to the stream bed impacting on things such as Invertebrate habitat and gravel beds used for Spawning by native Brown Trout. The pond banks are currently grazed by cattle which could cause more soil release into the stream in future.



We cannot ignore the objections raised by the agencies consulted and as a council it is our public duty to object to the application.

It was proposed to object to this application and support all the consultee agencies comments.

## a) Cornwall Councillor report

As the Local Government Association have recently held their AGM I thought I would share some of the points raised at the meeting with you.

Nearly 9 in 10 local Authorities fear that Nursery closures could affect them in the near future.

While all concerned are in favour of the Government funding package many fear it does not go far enough to protect the service in the long term.

Many of you will have seen the Council offering bus travel at a reduced cost over the last twelve months in an attempt to encourage more people to use public transport,

Nationally this scheme has cost local authorities £452 million in the last year the LGA believe the concessionary scheme is not fit for purpose and is preventing Councils from investing in the future of the service.

82% of councillors who responded to a recent survey said they felt at risk some or all of the time while carrying out their role.

The number of councillors who said they have suffered abuse has doubled in the last twelve months.

The LGA reports that increasing number of Councils are keen to introduce Hybrid meetings to support the retention of Councillors and also to enable more disabled members of the community to become members and fully engage with able bodied members.

One in ten councils said they had lost at least one member since the return to Face-to-Face meetings, However this would need a change In the laws that councils have to abide by at present.

The LGA have identified a funding gap of £3 billion that we would need to bring service levels back to pre-cut levels. There are many factors to consider as to why this has escalated in recent years.

Locally this last year has seen the levelling up funds in one guise or another give significant support to many local councils and other community groups and the next round will no doubt be oversubscribed again so my advice would be to do your homework early and build a robust application and business plan now that you know the pitfalls and the process should hopefully be a little easier.

With the CAP in mind the sub groups for the funding bids and the Highway schemes have been selected and we have a sub with a lot of experience who

will sit across both groups so I am confident that they are in a good place going forward.

I would like to personally thank those members that have taken up the challenge and I am confident in their ability to deliver for the benefit of all members. I recently attended the quarterly meeting of the Cornwall youth Council as a Councillor advocate and was very impressed with the progress made since our last meeting.

They have decided that the chair will stay in post for twelve months as opposed to changing every quarter.

Some of the group attended the last full council meeting and have decided to follow a similar format with regards the meetings they hold, although they were less than impressed with the way some members conducted themselves in the chamber so have made it clear that they will not tolerate such behaviour.

They intend to canvas all local schools to broaden membership of the youth council so if any of you know someone who may be interested, please let me now and I will contact the youth council officer to make the initial introduction.

Some of you will have no doubt seen the press release regarding an extra £9.1m that has been secured by the council for Highway improvements across the county although some of this extra funding has been earmarked for the Penwith CAP area. I have no knowledge of what schemes are proposed at present but as soon as this information is live I will make sure to inform you all.
