Councillor Mrs S Olds declared a prejudicial interest in minute no. TC.144 (St Just Garage) as she was related to the proprietor of the business and agreed to withdraw from the meeting for consideration of the item.

TC.143 PENWITH MOORS (EXEMPT PARAGRAPH 3)

The Town Council received a presentation from Ian Cooke, Save Penwith Moors concerning its request for the Town Council to hold a public meeting on the issue of fencing and grazing of moorland in West Penwith, with specific reference to Carnyorth Moor.

Mr Cooke gave an overview of the Heath Project which aimed to reverse the spread of bracken and gorse on the moorland via the introduction of the grazing of cattle and thereby improve public access to the moors. He stated that the group's main concerns related to the areas of Carnyorth Moor, the two National Trust properties of Watch Croft and Carn Galva, the two crofts on Lanyon Farm – Menan-Tol and Lanyon Quoit and referred to the report produced by John Waldon, Natural England's consultant which had acknowledged that there had been a lack of communication with local residents on the detail of the project.

The group maintained that as a result of the project and the introduction of cattle and gates the moors were becoming less frequented by visitors / walkers and horse riders.

Save Penwith Moors agreed that the moors needed to be conserved and managed but felt that this should be achieved by unobtrusive minimal maintenance by mechanical means, use of herbicides and the controlled burning of areas which would not deter access to the moors by the public.

lan Cooke urged the Town Council to support the group's request for a public meeting on the issues.

There then followed a question and answer session on the issues raised at which officers from Cornwall Council and the Chairman of PAROW participated.

At the conclusion of the debate the invited guests left the meeting and the Town Council considered the formal request by Save Penwith Moors.

<u>RESOLVED:</u> That a decision on whether to host a public meeting on Penwith Moors be deferred until a further meeting of the Town Council to give all Councillors the opportunity to consider the report produced by John Waldon.

At this point in the proceedings the meeting was brought back into public session.

TC.144 COUNCILLOR REQUEST FOR ITEMS TO BE PLACED ON THE AGENDA

St Just Garage

Councillor Mrs S Olds declared a prejudicial interest and withdrew from the meeting for consideration of this item.

Councillor East informed the Town Council that over the Feast weekend considerable traffic congestion had occurred as a result of the offloading of vehicles by St Just Garage at the top end of Fore Street which had also caused inconvenience to those people wishing to access Age Concern.

Councillor East felt that the situation was causing difficulty for traffic entering and exiting the town as well as pedestrians and that the situation needed to be improved. Councillor K McFadden acknowledged that occasionally there had been some difficulty as the garage vehicles parked on the double yellow lines, again causing traffic problems.

A site meeting was to be held with the landowner and representatives of Cornwall Council. It was suggested that it would be helpful if a representative from the Town Council also attended the

meeting.

TC.147 BOSAVERN FARM

Councillors Ms Angove and Thomas declared a personal interest in this item as members of the Board of Trustees of the Community Land Trust.

Councillor Mrs James declared a personal interest in this item as a trustee of the Community Land Trust.

Councillor Ms Angove reported that she had requested that the item be considered by the Town Council in view of the decision taken by Truro and Penwith Colleges to withdraw from discussions with Cornwall Council in respect of future educational use at the farm and to seek the Town Council's support for community ownership of the farm.

A local action group had been set up with the aim of retaining Bosavern Farm for the local community via a community action scheme. A leaflet setting out the group's aims had been circulated to local residents.

Councillor Goninan reported that a meeting was to be held with officers of Cornwall Council on Wednesday 11 November when it was hoped there would be some encouraging news with regard to the provision of allotments on the site. It was hoped that the public campaign for the retention of the farm would not adversely affect the delivery of the allotments.

Councillor James explained that the group had applied for funding towards the project and that there was considerable community support for an agricultural / educational use of the farm. This being so she felt that the Town Council should support "in principle" retaining some form of public ownership of the site together with a community supported agriculture and educational facility.

Following detailed consideration of the issues it was

<u>RESOLVED</u>: That the Town Council supports "in principle" community use of Bosavern Farm, subject to conditions regarding future use, demonstrable need and long term sustainability being met.
